Report of the Auditor General on Head 08 - National Police Commission - Year 2016

The audit of the Appropriation Account and the Reconciliation Statements including the financial records, books, registers and other records of the National Police Commission—Head 08 for the year ended 31 December 2016 was carried out in pursuance of provisions in Article 154(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka. The Management Audit Report for the year under review was issued to the Secretary to the Commission—on 14 June 2017. The audit observations, comments and findings on the accounts and reconciliation statements were based on a review of the Accounts and Reconciliation Statements presented to audit and tests of samples of transactions. The scope and extent of such review and tests were such as to enable as wide an audit coverage as possible within the limitations of staff, other resources and time available to me.

1.2 Responsibility of the Chief Accounting Officer for the Accounts and Reconciliation Statements.

The Chief Accounting Officer is responsible for the maintenance, preparation and fair presentation of the Appropriation Account, Revenue Account, and the Reconciliation Statements in accordance with the provisions in Articles 148, 149, 150 and 152 of the Constitution of the Democratic Socialist Republic of Sri Lanka, other Statutory Provisions and Public Finance and Administrative Regulations. The responsibility includes; designing, implementing, maintaining internal control relevant to the preparation and fair presentation of Accounts and Reconciliation Statements that are free from material misstatements whether due to fraud or error.

2.1 Appropriation Account

Total Provision and Expenditure

The total net provision made for the National Police Commission amounted to Rs. 88.85 million and out of that Rs. 85.35 million had been utilized by the end of the year under review. Accordingly, the savings out of the net provision of the Commission amounted to Rs. 3.50 million represented 3.94 per cent of the net provisions. Details are given below.

Budgetary Variance

The entire net provision amounting to Rs. 150,000 made for one Object had been saved.

3.2 Conduct of Annual Boards of Survey

Action in terms of the provisions of Financial Regulation 770 had not been taken even as at 31 May 2017 in respect of the goods unusable and should be written off from books which had been shown by the Annual Boards of Survey Report in the year 2015.

(b) Establishment and Disciplinary Control

The Establishment and Discipline Section had been implemented under the National Police Commission for the proper execution of the activities on formulation of policies for all the matters such as recruitments, appointments, promotions, transfers confirmation to the service, service extension disciplinary control and retirements of the Officers from the post of Assistant Superintendent of Police up to the post of Senior Deputy Inspector General of Police included in the category of Gazetted Officers of the Police Service, from the post of Police Constable up to the post of Chief Inspector which is not included in the category of non-gazetted Officers. The following observations are made in this connection.

(i) Conduct of Disciplinary Inquiries for the Gazetted Officers.

The files received for the disciplinary inquiries for the year under review were 202 and 44 files out of that or 22 per cent completed and the Disciplinary Orders had been issued. Five files had been completed in the expectation of issuing disciplinary orders which the disciplinary inquiries completed on 30 May 2017. The number of files which the disciplinary orders are pending, number of draft charge sheets received and the files in progress had been 153 or 76 per cent.

(ii) Inquiry of Complaints and Appeals in respect of the Vacation of Post and Disciplinary Actions for the Non-gazetted Officers
